

**The Sixt(h) For Free Sweepstakes
TERMS & CONDITIONS**

THIS IS A CLOSED SWEEPSTAKES OPEN ONLY TO INDIVIDUALS WHO MEET ALL ELIGIBILITY REQUIREMENTS AS MORE FULLY EXPLAINED IN THE ELIGIBILITY SECTION BELOW. VOID WHERE PROHIBITED BY LAW.

BY PARTICIPATING IN THIS SWEEPSTAKES, YOU AGREE TO THESE TERMS & CONDITIONS (“TERMS”), WHICH ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE PARTICIPATING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO SIXT FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

OVERVIEW: The **Sixt(h) For Free Sweepstakes** (the “**Sweepstakes**”) is sponsored by Sixt Rent a Car LLC, who has a principal place of business at PO Box 460967, Fort Lauderdale, FL 33316 (“**Sixt**”), during the Sweepstakes Period as defined below, for eligible participants in accordance with all instructions in these Terms. Provided that you have complied with and are eligible in light of the requirements set forth in these Terms and subject to the disclaimers set forth in these Terms, you will be entered for a chance to win one of the following prizes: (1) for Prepaid Reservation Submissions, a Free Reservation where the winner will receive a refund for the total cost of their prepaid reservation up to a maximum of Three Hundred US Dollars (\$300.00), or (2) for Postcard Submissions, the winner will receive a Voucher for a future rental which shall cover the rental costs up to a maximum of Three Hundred US Dollars (\$300.00) (each individually a “**Prize**”).

SWEEPSTAKES PERIOD: The Sweepstakes starts **September 23, 2016** at 9:00:01 AM United States Eastern Time (the “**Sweepstakes Start Date**”) and ends **September 25, 2016** at 11:59:59 PM United States Eastern Time (the “**Sweepstakes End Date**”) (together this period shall be referred herein as the “**Sweepstakes Period**”). All eligible Prepaid Reservation Submissions must be made and entered through the Confirmation Page during the Sweepstakes Period and all Postcard Submissions must be postmarked no later than Monday September 26, 2016 to be entered for a chance to win.

HOW TO ENTER/SUBMISSION REQUIREMENTS: Your Submission must meet all of the requirements in these Terms, including the following, or the associated Submission will be deemed ineligible. There are two (2) methods of entry, each with their own Submission requirements. An eligible participant may enter either (i) by prepaid reservation entry (each a “**Prepaid Reservation Submission**”) or (ii) by postcard entry (each a “**Postcard Submission**”) (both Prepaid Reservation and Postcard Submissions may be referred to collectively as “**Submissions**”).

(i) Prepaid Reservation Submission: To participate in the Sweepstakes by Prepaid Reservation Submission, an eligible participant (see Eligibility section below for requirements) must make a prepaid reservation by clicking the “Pay Now” option through www.sixt.com/sixthforfree (the “**Landing Page**”) with a United States IP address during the Sweepstakes Period. All prepaid reservations made on the Landing Page may be entered for a chance to win by entering the applicable reservation number and security code on the Confirmation Page as described further below. If you do not want to participate you should not use the Landing Page to secure your reservation. This reservation must schedule a pick up date between September 25, 2016 and December 31, 2016 and the Sixt branch selected as the pick up location must be at one of Sixt’s corporate or participating franchise locations in the USA, Austria, Belgium, France, Germany, Luxemburg, the Netherlands, Spain, Switzerland, and UK to be entered for a chance to win. The prepaid reservation must also be made using Sixt regular retail rates. Prepaid reservations made with contracted corporate, wholesaler, or other special offer rates will not be eligible for entry. All eligible prepaid reservations must be made with accurate contact and payment information. By securing your prepaid reservation through the Landing Page, you agree to the Sixt rental terms and conditions, rental information, and privacy policy. If you do not agree to those terms, you should not make a reservation. Once your eligible prepaid reservation is complete, you will receive a reservation number and security code and you will be directed to a secondary webpage, www.sixthforfree.sixt.com (the “**Confirmation Page**”). The Confirmation Page will allow you to enter your reservation number and security code to enter for a chance to win!

(ii) Postcard Submission: To participate in the Sweepstakes by Postcard Submission, an eligible participant (see Eligibility section below for requirements) must send a postcard with the participant's first and last name, phone number, mailing address, email address, and the name of this Sweepstakes to the address listed below this paragraph. Such postcard must be postmarked no earlier than September 23, 2016 and no later than September 26, 2016. Such postcard must be received by the Winner Selection Date as set forth below:

For all Submissions, Sixt is not responsible for misspellings, typographical errors, or other issues that may prevent a Submission from being an eligible Submission or being submitted in a timely manner. Your Submission will not be deemed eligible by Sixt until Sixt verifies that it meets all the Submission Requirements herein and otherwise complies with these Terms. Sixt, at its sole discretion, may accept or disqualify a Submission that is accompanied by a technically incorrect required term. There is no limit on Prepaid Reservation Submissions made by any one (1) participant. However, any one (1) participant entering via Postcard Submission is limited to only one (1) Postcard Submission per day. Attempts made by a participant to make a Submission in violation of these Terms or with false contact or payment information may be disqualified. Incorrect and/or incomplete attempts at participation or those Submissions identified or received outside the Sweepstakes or other applicable Period, will be void and not eligible. For purposes of this Sweepstakes, Prepaid Reservation Submissions are "received" automatically upon an eligible participant entering a eligible prepaid reservation number and security code on the Confirmation Page and for Postcard Submissions, upon Sixt's receipt of the participant's postcard. Facsimiles, mechanical reproductions, alterations, garbled, incomplete, misdirected, lost, late, mutilated, or forged Submissions will not be accepted and are void. Those who do not follow all of the instructions, provide the required information in their Submission or abide by these Terms will be disqualified. Submissions will not be acknowledged. As a condition of entering the Sweepstakes, each participant gives consent for Sixt and its representative to obtain and deliver his or her name, address and other information to third parties for the purpose of administering this Sweepstakes and complying with applicable laws, regulations and rules. Submissions may only be submitted by individuals. In the event of a dispute concerning the identity of a participant, the participant will be declared to be for Prepaid Reservation Submissions, the individual whose name appears on the credit card provided to secure the prepaid reservation and for Postcard Submissions, the individual whose name appears on the postcard. If a dispute cannot be resolved to Sixt's satisfaction, in its sole discretion, the Submission will be deemed ineligible.

ELIGIBILITY REQUIREMENTS: This Sweepstakes is open only to legal residents of any one (1) of the fifty (50) United States or the District of Columbia who are at least twenty-one (21) years old as of the date of participation. All participants must have a valid driver's license and credit card at the time of the rental. All drivers shall be required to comply with Sixt driver qualifications and further requirements according to general terms and conditions of Sixt's rental agreement and policies. Sixt reserves the right to deny a vehicle to any participant that does not comply with Sixt rental policies and the terms and conditions of its rental agreement. Corporate entities are not eligible and have no right to claim any Prize awarded to their employees. Employees, officers, directors, members, managers, agents, and representatives and family members of such individuals (or people living in the same household whether related or not) of Sixt and their respective corporate partners, parent companies, divisions, subsidiaries, affiliates, successors in interest, advertising, Sweepstakes and public relations agencies (collectively, the "**Sweepstakes Entities**") are not eligible. For purposes of this Sweepstakes, family members are defined as spouse, domestic partner, mother, father, legal guardian, in-laws, grandmother, grandfather, brother, sister, children and grandchildren. This Sweepstakes is void in all U.S. territories (including Puerto Rico), possessions and overseas military installations, and where prohibited by law.

WINNER SELECTION & NOTIFICATION: Sixt will be selecting up to Four Hundred (400) winning Prepaid Reservation Submissions and up to Four Hundred (400) winning Postcard Submissions.

(i) Prepaid Reservation Submission: For Prepaid Reservation Submissions, one (1) in six (6) prepaid reservations entered through the Confirmation Page will be eligible for the Free Reservation Prize, as described in more detail in the Prize section below. In determining the winning Submissions, Sixt will count only the prepaid reservations made and entered through the Confirmation Page by eligible participants in strict compliance with the requirements herein beginning on September 23, 2016 at 9:00:01 AM United States Eastern Standard Time, the Sweepstakes Start Date. One (1) in six (6) qualifying Submissions will be randomly selected as a winner. Upon identifying a winning Prepaid Reservation Submission, the winning participant will receive a courtesy email notification from Sixt indicating that they have won. Notwithstanding the foregoing, the participant will not actually receive the refund unless or until the participant arrives to pick up the rental vehicle with a print out of the courtesy email sent by Sixt. In the event the participant arrives as described above, Sixt shall refund the winner through the credit card used at the Sixt counter to secure the rental with such refund in the amount of the initial reservation up to Three Hundred US Dollars (\$300.00). In the event the participant does not arrive to pick up the rental vehicle or does not bring the courtesy email, any applicable cancellation or no show fees shall apply, and the renter will not be eligible for the Prize, prize value or a refund of any amounts paid. The winner's refund will be processed within thirty (30) days from the date the rental vehicle is picked up from the Sixt location. Please see Prize section for further restrictions.

(ii) Postcard Submission: For Postcard Submissions, one (1) in six (6) Postcard Submissions received by Sixt by the Winner Selection Date will receive the Voucher Prize, as described in more detail in the Prize section below. In determining the winning Submissions, Sixt will count only the postcards sent by eligible participants in a timely manner and otherwise in strict compliance with the requirements herein. Such postcards must be postmarked by September 26, 2016 and must have been received by Sixt at the address described in the Submission Requirements above by October 3, 2016 (the "**Winner Selection Date**"). One (1) in six (6) qualifying Submissions will be randomly selected as a winner. Upon identifying a winning Postcard Submission, the winning participant will receive a courtesy email notification to the email address provided in the postcard which shall attach the electronic Voucher Prize with a value of Three Hundred US Dollars (\$300.00). To use the Voucher, the participant must agree to the terms and conditions of that Voucher as well as the rental information and terms and conditions applicable to their rental. In the event the participant does not agree to such terms or does not use the Voucher in a timely manner the participant will not be eligible for the Prize, prize value or a refund of any amounts. Please see Prize section for further restrictions.

For all Submissions, Sixt reserves the right to contact participants for verification purposes and administration of the Sweepstakes. If (a) the potential winner cannot be contacted, (b) any Prize or prize notification is returned as undeliverable, (c) the potential winner is found to be ineligible, or (d) the potential winner does not comply with the Terms herein, then the potential winner may, in Sixt's sole discretion, be disqualified. No substitute Prizes need be given.

PRIZE:

(i) Prepaid Reservation Prize: The winning Prepaid Reservation Submissions will be awarded a Free Reservation Prize! Free Reservation is defined as the total cost of the participant's initial prepaid reservation, up to Three Hundred US Dollars (\$300.00) including taxes and fees ("**Free Reservation Prize**"). This Free Reservation Prize does not include and Sixt shall not refund the winning participant for (a) any fees or costs listed on the prepaid reservation above and beyond Three Hundred US Dollars (\$300.00) or (b) any fees or costs not originally purchased or calculated at the initial online reservation stage and listed on the prepaid reservation confirmation. Such fees and costs include but are not limited to costs for extensions, upgrades, insurance, fuel, delivery and service charges, additional mileage, express tolls, and all other extra, ancillary, or incremental sales products offered by Sixt. The Free Reservation Prize shall be awarded to the winning participant by way of refund to be processed to the credit card used at the Sixt counter to secure the rental within thirty (30) days from the date the winner arrived at one of our Sixt corporate locations to pick up the rental. The approximate retail value of each Prepaid Reservation Prize is up to Three Hundred US Dollars (\$300.00).

(ii) Voucher Prize: The winning Postcard Submissions will be awarded a Three Hundred US Dollar (\$300.00) Voucher! The Voucher shall, upon presenting the Voucher at a participating Sixt location, reduce the amount due and owing from the renter for a car rental in an amount up to Three Hundred US Dollars (\$300.00) (the "**Voucher**"). Sixt does not guarantee any particular make or model of vehicle and vehicles are subject to availability. If the car rental costs less than Three Hundred US Dollars (\$300.00) the rental will be free of cost for the renter. However, please note that any fees or costs incurred by the winning participant above and beyond the amount of the Voucher's Three Hundred US Dollar (\$300.00) value including but not limited to costs for extensions, upgrades, insurance, fuel, delivery and service charges, additional mileage, express tolls, and all other extra, ancillary, or incremental sales products offered by Sixt shall not be discounted by Sixt and shall not be included in the Voucher Prize. The Voucher shall be issued to the individual whose name is listed on the winning postcard and shall not be transferable.

For all Prizes, any details not specified in these Terms will be determined by Sixt in its sole discretion. Any taxes (federal, state, and local) and all costs and expenses associated with Prize acceptance or use and not specified in these Terms as being part of the Prize will be the sole responsibility of any winner. Any winner may be issued a 1099 and related tax forms for the actual value of the Prize. No more than the stated Prize will be awarded. Sixt will not replace any lost or stolen Prize or Prize elements or any Prize that is undeliverable or does not reach any winning participant because of incorrect contact or payment information. If a winning participant does not accept or use the entire Prize, the unaccepted or unused part of the Prize will be forfeited and Sixt will have no further obligation with respect to that Prize or portion of the Prize. No transfers, Prize substitutions, or cash redemptions will be made, except at Sixt's sole discretion. Each winning participant is strictly prohibited from selling, auctioning, trading, or otherwise transferring any part of the Prize, except with Sixt's permission, which may be granted or withheld for any reason in its sole discretion. Sixt reserves the right to substitute any Prize or portion thereof with another prize or portion thereof of equal or greater value for any reason, including unavailability of the stated Prize. Each participant waives the right to assert, as a cost of winning any Prize, any and all costs of verification and redemption or travel to claim the Prize and any liability and publicity which might arise from claiming or seeking to claim said prize. Each Prize has an approximate retail value of up to Three Hundred US Dollars (\$300.00). Sixt will select up to Four Hundred (400) winning participants from the Prepaid Reservation Submissions and Four Hundred (400) winning participants from the Postcard Submissions. Therefore, the total retail value of the Prizes in this Sweepstakes can amount to up to Two Hundred Forty Thousand US Dollars (\$240,000.00).

SECTION 1542 READS AS FOLLOWS: "CERTAIN CLAIMS NOT AFFECTED BY A GENERAL RELEASE. A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS WHICH THE CREDITOR DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, WHICH IF KNOWN BY HIM OR HER MUST HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR."

ADDITIONAL DISCLAIMERS: Released Parties are not responsible and/or liable for any of the following, whether caused by a Released Party, the participants or by human error. Submissions that are submitted by illegitimate means; any lost, late, incomplete, illegible, mutilated, or misdirected Submissions, e-mail, mail, or Sweepstakes-related correspondence or materials or postage-due mail; any error, omission, interruption, defect, or delay in transmission or communication; viruses or technical or mechanical malfunctions; interrupted or unavailable cable or satellite systems; errors, typos or misprints in these Terms, in any Sweepstakes-related advertisements or other materials; failures of electronic equipment, computer

hardware or software; lost or unavailable network connections, or failed, incorrect, incomplete, inaccurate, garbled or delayed electronic communications or Submission information including, without limitation messages from Sixt that are segregated into the "Other" folder of entrant's inbox. Released Parties are not responsible for any changes to the ability of participant to timely participate, receive notices or communicate with Sixt, in which case Sixt, in its sole discretion, may terminate or modify the Sweepstakes. Released Parties are not responsible, and may disqualify a participant, if his or her e-mail address, telephone, or other contact information or credit card information does not work or is changed without participant giving prior written notice to Sixt. All participants, as a condition of participating, agree to be bound by these Terms and the decisions of Sixt. Failure to comply with these Terms may result in disqualification from this Sweepstakes. Sixt reserves the right to restrict or void online participation from any IP address if any suspicious participation is detected. If any person supplies false information, makes a Submission by fraudulent means or is otherwise determined to be in violation of these Terms in an attempt to obtain a Free Reservation or Voucher Prize, Sixt may disqualify that person and seek damages from him or her and that person may be prosecuted to the full extent of the law. Sixt's failure to or decision not to enforce any provision in these Terms will not constitute a waiver of that or any other provision. In the event there is an alleged or actual ambiguity, discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials and/or these Terms (including any alleged discrepancy or inconsistency in these Terms), it will be resolved in Sixt's sole discretion.
